Proposed Sandown Racecourse Redevelopment

Information Sheet



Melbourne Racing Club (MRC) is proposing changes to the Greater Dandenong Planning Scheme to facilitate the redevelopment of the Sandown Racecourse.

The Minister for Planning has decided to progress the draft planning scheme amendment to facilitate the proposal through a process led by the state government.

The Minister for Planning has established the Sandown Racecourse Advisory Committee to provide advice about the proposal and to consider any public submissions made, before the Minister decides whether to approve a planning scheme amendment.

Site details

Sandown Racecourse, located at 591-659 Princes Highway, Springvale, is approximately 112 hectares in area. The site is about 1 kilometre from the Springvale and Noble Park Major Activity Centres and 5 kilometres from the Dandenong Metropolitan Activity Centre and the Monash National Employment and Innovation Cluster. The site adjoins the Sandown Park train station.



What is being proposed?

The proposal seeks to enable the redevelopment of the land for predominantly residential use including approximately 7,500 homes, supported by community facilities, open space and commercial and retail uses.

The draft planning scheme amendment proposes to make changes to the Greater Dandenong Planning Scheme to facilitate this proposal, including to:

- Rezone the site from the Special Use Zone, Urban Floodway Zone and General Residential Zone to the Comprehensive Development Zone.
- Apply the Development Contributions Plan Overlay.
- Apply the Environmental Audit Overlay.
- · Remove the Heritage Overlay.
- Introduce the Sandown Racecourse Comprehensive Development Plan.
- Introduce the Sandown Racecourse Development Contributions Plan.

Submissions should relate to the proposal and draft planning scheme amendment.

All submissions must state the name and address of the person making the submission and will be treated as public documents. If submissions are published publicly, personal information will be redacted first (except your name).

What happens next?

The Sandown Racecourse Advisory Committee will conduct a public hearing process following the consultation period, including a directions hearing to discuss arrangements for the main hearing.

Dates for the public hearing process will be confirmed after consultation. The following timeframes are indicative only:

What is the Sandown Racecourse Advisory Committee?

The committee was appointed by the Minister for Planning on 2 March 2024 to advise on all relevant matters associated with the proposed redevelopment of Sandown Racecourse.

Can I make a presentation at the hearing?

If you make a submission, you will have an opportunity to present your views to the committee. To participate in the hearing, you must request in your submission that you would like to be heard. Anyone may observe the hearings.

What is the role of the Greater Dandenong City Council for this process?

The request for a planning scheme amendment was originally submitted to the council to facilitate the proposed redevelopment. The council submitted the request to the Minister for Planning for authorisation to prepare this amendment. The Minister instead decided to go through a process led by the state government (the current process).

The council is a key stakeholder and will participate in the committee process. However, the council is not leading the draft planning scheme amendment process.

Will horse racing and motorsport continue at the site?

The current process is to consider the potential redevelopment of the land.

Any changes to horse racing or other existing uses such as motorsport will be subject to future decisions by Racing Victoria and Melbourne Racing Club members.
